BYLAWS

UNITED TRANSPORTATION UNION LOCAL NO. 0329

SECTION I

This Local shall be known as United Transportation Union Local No 0329.

Regular meetings shall be held on the 2nd Wednesday of each month at 0900 a.m. in the Meeting Hall at The Golden Corral, 1312 S. Story St., Boone, IA 50036 subject to change as provided in Article 55.

The order of business shall be as set forth in Article 77.

SECTION II

Local dues of in-service members shall be \$8.00 per month, subject to change as provided in Article 48. The initiation fee for new members shall be \$1.00.

SECTION III

The President of the Local shall be paid a quarterly salary of \$40.00.

The Secretary/Treasurer of the Local shall be paid a monthly salary of \$300.00.

The Board of Trustees shall be allowed one (1) day's pay, at the daily rate applicable to the class of service in which regularly assigned, for the performance of duties as specified in Article 67, Constitution.

The provisions of this Article are subject to change as provided in Article 48.

SECTION IV

The Secretary shall arrange for flowers or for a contribution to a designated charitable research or fraternal organization, in honor of deceased members at a cost not to exceed \$100.00.

If the Secretary is not available, another officer of the Local shall assume this duty.

SECTION V

All disbursements from the Local fund shall be made by check. Disbursements, except as provided in these by-laws, shall be approved by the Local before disbursement is made.

No expense will be allowed for attending Regional Meetings, seminars, or other similar meetings unless attendance is approved by the Local prior to such meeting.

No disbursements will be made unless proper documentation detailing expenses and lost time is provided.
Expenses will be submitted at the next regular meeting after the expenses have occurred.

SECTION VI

Regular election for officers and committeemen shall be by secret mail referendum ballot, except the Alternate Delegate shall be elected by secret ballot at a regular meeting after the referendum election is completed.

Permanent vacancies, except as provided in Article 57, shall be filled by secret ballot of the eligible members present at a regular or special meeting.

All elections shall be conducted in accordance with the provisions of Article 57 and special instructions from the International.

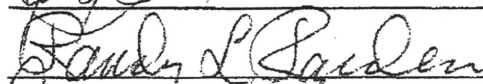
SECTION VII

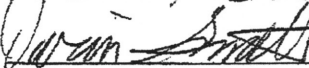
After giving reasonable notice to all eligible voters, these bylaws will be read at two regular meetings and, if approved by a majority of the members present at each meeting voting by secret ballot, shall become effective, and supersede any existing bylaws on the first day of the month following the approval of the International President.

Amendments to these bylaws shall be handled in the same manner. These bylaws were adopted this 14th day of October 2011.

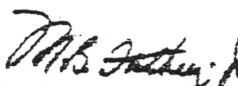
